4.) The entry remains on display through the Simsbury Celebrates event and should be **picked up Sunday, November 27, 2011 between 12-2 PM unless I/we have checked that we have donated it to the committee.**

Permission is hereby granted to Simsbury Celebrates Gingerbread House Committee to print or otherwise duplicate the picture or likeness of the entry and/or the entrant with the entry for either internal or external release; this includes print and online publications as well as local television.
